


## The Good from Giving

The impact your annual gifts to the Depot Foundation make not only helps preserve the arts, history and culture of our community - it also empowers the Depot's Participating Member Organizations (PMOs) to accomplish great things for our community! This spring, the Depot Foundation highlights the incredible success story of the Duluth Playhouse – Children's Theatre and their nationally recognized program Stage Play, a program that serves children from all over the Northland who are living with autism spectrum disorder (ASD).

Kate Horvath, Artistic Director of Duluth Playhouse Children's Theatre, tells us that the Depot Foundation's that support is leveraged to great effect:

"Stage Play is a collaboration with professional staff from The Scottish Rite Clinic for Childhood Language Disorders and is housed in the Underground Theatre at the Historic Union Depot. Stage Play is a tuition-free outreach program that pairs one teenaged mentor with an individual student on the spectrum. Teens engaged as volunteers find the experience as rewarding and educational as the young charges they "buddy" each week. Stage Play combines theatre and traditional therapy methods that result in a one of a kind experience that builds confidence, communication, and social skills in youth with ASD".





Recognizing that by its very nature, theatre has the ability to enhance our lives in many ways and particularly those who live with autism. According to Kate Horvath, "Theatre naturally lends structure for creative play so students can safely engage, discover, and practice 'imaginary solutions to real life problems.' Students delight in learning new ways to communicate, developing vocabulary and building self-confidence. Stage Play has had six years of success as the only artscentered community program specifically serving youth with autism in the region".
